Further to our correspondence of August 6, seeking the Australian Government's intervention at the arrest of Ukraine's opposition leader Yulia Tymoshenko and call for her immediate release, we provide the attached information about current international reaction to the situation.

Over the past 48 hours, the European Parliament, the Governments of USA, Canada, France, Poland, Sweden, Germany, Russian and Great Britain have voiced expressed their concerns publically.

Peak bodies such Freedom House, the Ukrainian World Congress, the Ukrainian Congress Committee of America, Association of Ukrainians in Great Britain, Ukrainian Canadian Congress, Australian Federation of Ukrainian Organisations have all issued statements which are now posted on various news sites internationally.

We call on the Australian Government to join this list.

I will be travelling to Ukraine on Tuesday August 9, 2011and have commenced enquiries about the possibility of visiting Yulia Tymoshenko to relay the support of Australia's Ukrainian community.

#### Germany concerned by the arrest of ex-premier Yulia Tymoshenko.

This statement by the Ministry of Foreign Affairs of Germany, sends "Ukrainian News".

The corresponding statement was made Vice-Minister and Minister of Foreign Affairs of Germany Werner Hoyer.

"The federal government approved the arrest today of the Ukrainian opposition leader Yulia Tymoshenko with great concern. There is doubt that the detention is proportionate to conduct" - he said.

Hoyer also noted that the fact that many former officials in Ukraine are under investigation for abuse of authority, suspicious of the political motivation of the judiciary in Ukraine.

"Further strengthening this impression would be a significant obstacle to

rapprochement between Ukraine and EU", - he said.

The Minister also urged the Ukrainian government to ensure a fair process of law and independent legal system.

STATEMENT BY SENATOR JOHN McCAIN REGARDING THE DETENTION OF FORMER UKRAINIAN PRIME MINISTER YULIA TYMOSHENKO

Washington, D.C. - U.S. Senator John McCain (R-AZ) today released the following statement regarding the Ukrainian government's detention of political opposition leader and former Prime Minister Yulia Tymoshenko:

"I am deeply concerned about the detention today of former Prime Minister Yulia Tymoshenko in Ukraine. This action is clearly a violation of the basic rights that should be protected for every citizen in a democracy. The implications of this detention go far beyond the fate of one person. Ultimately, what is at stake is the future of freedom and democracy in Ukraine. Unfortunately, today's action by the Ukrainian government calls into question its commitment to the fundamentals of democracy, and as such, will make Ukraine's path toward a future in the Euro-Atlantic community harder to achieve. I urge the leadership in Kyiv to release Prime Minister Tymoshenko immediately and guarantee the rights of all Ukrainians, regardless of their political beliefs."

#### French Foreign Ministry expresses concern over arrest of Tymoshenko

France is deeply concerned by the arrest of former Prime Minister of Ukraine, leader of the party "Rodina" Yulia Tymoshenko.

This is stated in the special request of the Ministry of Foreign Affairs of France, to the press service of "homeland."

"France is deeply concerned by the arrest of Tymoshenko. We raise doubts about the motives of this trial "- the document says.

"In particular, we think that there was no enforceable right to protection", - noted in the Ministry of Foreign Affairs of France.

"As we have repeatedly emphasized respect for the rule of law is a key element in building a partnership between France, the European Union and Ukraine", - reads the statement.

The Foreign Ministry stressed that France and its European partners will continue to closely monitor the situation with Tymoshenko.

## Group President of the European People's Party and Christian Democrats in the PACE Luc VOLONTE condemns arrest of former Prime Minister, leader of the party "Rodina" Yulia Tymoshenko.

"The arrest of Yulia Tymoshenko is an act of tyranny and the continuation of unilateral actions of Ukrainian justice against the opposition" - the statement reads L. VOLONTE, reported on the website Tymoshenko.

"I asked President Yanukovych with a request to allow Yulia Tymoshenko to visit the EPP Group seminar at the next plenary session in Strasbourg. This arrest is a clear answer to the leadership of the Presidency of the Committee of Ministers of the Council of Europe. Ukrainian government does not want the leader of the opposition participated and took active role in public debates in Ukraine and European countries "- said in the statement.

According to L. VOLONTE, arrest TYMOSHENKO not only violates all European standards, but is the wrong solution to Ukraine's future in Europe. "It is similar to inappropriate use of justice for political purposes. The only purpose of these actions of harm and intimidate the opposition in Ukraine. The Ukrainian government should immediately release Yulia Tymoshenko and give her permission to participate in our family EPP Workshop to be held in plenary session October "- he said.

FCO concerned at the arrest of ex-Prime Minister of Ukraine Yulia Tymoshenko.

## The report contained statements Office of Deputy Foreign Minister of Great Britain Alistair Bertha, reports Interfax-Ukraine.

"I was very concerned about the situation with the detention of Ukrainian opposition politician Yulia Tymoshenko on August 5," - he said.

The Foreign Ministry stressed that Britain, together with EU and international partners will continue to monitor the trial of Tymoshenko, as well as on cases against several former ministers of government and its officials.

"I urge Ukrainian authorities to adhere to the highest democratic standards, including those relating to human rights law and ensure independent, transparent and fair trial.

They - the prerequisites for closer integration of Ukraine and the EU" - said Deputy Foreign Minister of Great Britain.

In addition, the Canadian Foreign Ministry expressed its concern about the situation with the arrest said.

"Canada is concerned about the obvious political persecution, and now the arrest of Yulia Tymoshenko", - the comments Foreign Minister of Canada John Byrd, published on the Office's website.

According to the head of the Canadian Foreign Ministry, the appearance of political influence on litigation undermines the rule of law.

"Canada urges the Ukrainian government to strengthen judicial independence and continue to direct efforts to build a peaceful, democratic and secured society in Ukraine", - said Baird

#### <u>Ukrainian World Congress Calls for the Immediate Release of Yulia</u> <u>Tymoshenko</u>

Today's arrest of Ukraine's former Prime Minister and main opposition leader, Yulia Tymoshenko, during her trial, which is widely viewed as politically motivated, is a major step backwards for the government of Ukraine. Given that Ukraine is representing Europe as Chair of the Committee of Ministers of the Council of Europe until November 2011, co-host of EURO 2012, and Chair of the Organization for Security and Co-operation in Europe in 2013, it is critical for Ukraine's government to release Ms. Tymoshenko immediately, to comply with its international commitments, and to refrain from using criminal proceedings as a means to achieving political ends
