# CALL ON MEMBERS OF PARLIAMENT TO OPEN AN AUSTRALIAN EMBASSY IN KYIV

As you will be aware the Joint Standing Committee on Foreign Affairs, Defence and Trade and its sub committee are holding an inquiry into Australia's Overseas Representation .

On Friday February 17, 2012 the Chargé d'affaires of the Embassy of Ukraine in Canberra, Mr Stanislav Stashevskyi and Australian Federation of Ukrainian Organisations (AFUO) Chairman, Stefan Romaniw OAM, gave evidence at a Parliamentary Hearing of the Sub-Committee.

The Committee has been meeting regularly. We attach a link to Hansard which reported on proceedings on February 10, 2012. At that hearing Michael Danby MP, Member for Melbourne Ports raised the issue of the Post in Kyiv.(Please read.)

### What to argue?

An Embassy in Kyiv would increase bilateral relations, trade, opportunities for skilled labour market to be increased, potential for full fee paying students to study in Australia, increased tourism to Australia, that the region has great potential and this has been underestimated by Australia. Australia is the only country in the G20 group without representation in Kyiv.
